### IV. FINANCIAL REPORT

1. Rachel Denton was absent but emailed Financial Reports prior to Board meeting. There was a total of 24 delinquencies - Two (2) w/liens. For reference, in April 2021, 16 delinquencies – Two (2) w/liens.

- C. Reserves \$46085.71
- D. Delinquencies *\$3,664.36*
- E. Lien approved by the Board \$2,227.61
- 2. For reference, bank account balance in April 2021 at month end was \$45,284.56
- 3. 2021 990-N tax postcard filed
- 4. Snow removal costs more significant this year. Board should consider either reallocating funds from bank account to snow budget or possible re-assessment
- 5. Now on track with Glass Bandit invoices (two months recorded in February).
- 6. Tom has questions regarding snow removal assessments and asked that the information be carried over to the next meeting.
