BIG EVENT FOR OUR NEIGHBORHOOD!

It was suggested by a resident and received great acceptance at the annual meeting that we hold a "shred" event for Blue Hills Estates residents, SO that is what we are doing. This event will be held on Saturday, October 24th, from 9:30A to 11:30A. Thanks to Board members Joe Quinly and Greg Morlan, they have also agreed to collect household recyclable items that the City will accept and haul them to the Environmental Recycle Center located at 4707 Deramus in the riverfront area for our residents during this event, PLEASE see a list of items accepted and our restrictions below. This event will take place on Island #2, located across the street from 12640 Oakmont Drive.

For the shred truck:

- Residents are limited to personal shred items, no business volume as this event does not carry the same compliance regulations as a business shred situation.
- Each household is limited to no more then five boxes/bages of shredding, that is a limit of five total.

For the recycle items:

- Clear glass
- Brown glass
- Green glass
- Aluminum cans
- Tin
- Newspaper
- Magazines
- Press board (cereal and food boxes)
- Corrugated cardboard
- Plastics #1 & #2
- Toner and inkjet cartridges
- Old paint cans
- Pesticide cans and bottles

- NOTE: If you have a question on an item outside this list, please contact the City and ask before bringing your item. We also ask that if you can get rid of something through the normal trash pickup please do that versus bringing it to this event.

ANNUAL MEETING NOTES:

August 1, 2015 Meeting Blue Hills Estates Homes Association Minutes of the Annual Meeting

Items discussed:

- 1. Jim W. opened the meeting at 4P and welcomed the residents in attendance and provided a general introduction to the agenda.
- 2. Greg Morlan talked about the Crime Watch/Children Playing signs that had been posted in the neighborhood and also provided information on how to check street light polls for rust and who to call if a replacement was needed.
- 3. Dan French gave an update on the new online directory that is in the process of being launched, anticipated ready date is September 1 and instructions will be given to all residents via the September newsletter.
- 4. Joe Quinly provided an overview of the real estate market within Blue Hills Estate noting that two homes are currently under contract, one on Oakmont receiving a contract for more than the asking price on the first day on the market. The prior 18-months only six homes in the subdivision had changed ownership. Joe offered his services to anyone interested as he is a professional realtor.
- 5. Jim Rendina covered the proposed budget for the 2015-16 year and there was some general discussion among the members, including problem spots on the streets of Duke Gibson and 130th Terrace at the top of the hills when there is freezing temperatures and ice forms or snow gets packed. It was noted that our annual dues are locked and can't be raised, and that our snow budget is \$4,000 per year in contrast to some of our neighboring sub-divisions who have budgets four and five times that per year. There was talk among some of the residents on those blocks to get a private contractor to help with those two spots and pay it themselves, also it was mentioned that the city's 3-1-1 line seems to be pretty responsive for matters such as that.
- 6. Jim Wilson reminded residents of the social budget and asked that they be creative will activities for the neighborhood. This led to Dan French and Jim launching the idea of holding a "document shredding" event in the Fall, possibly in connection with some recycling which was met with great approval by those in attendance. Other discussion was asked for and one subject of "rodents" in the neighborhood emerged. An exterminator that had worked at one house suggested not putting trash out until the actual morning it was to be picked up. Possums and raccoons especially will be drawn to places where food is more easily found then in their more wilderness native environment. It was also noted there appears to be coyotes nestled in the woods to the east of the homes on Duke Gibson, between our neighborhood and the retirement/assisted living facility at the corner of Blue Ridge and Wornall, so please be cautious with house pets and children as they run in a pack, five were seen in the cul-de-sac not long ago.

The annual meeting was adjourned at 4:55 PM and a Special Meeting for dues assessment was immediately opened in a separate session.

In the special meeting it was voted upon that annual dues would be \$75 for the upcoming year.

As always, please keep a watchful eye for any suspicious activity and call the police if you suspect a crime. Also, you will see positngs on "Next Door" for the police department from Sarah Boyd, she is a community officer for the whole city.
