NOTES FROM THE PRESIDENT: Cyrus Hund

Dear Fellow Neighbors,

Although the world continues in its usual dynamic of crisis, conflict, solution (and sometimes improvement?), business and life in the Country Club District has been pretty smooth...with one exception. Below, I offer my explanation of an issue that arose in 2020 that was a priority of our board through 2021.

Update on Racially Restrictive Covenants:

As you may have read, the Missouri Attorney General's Office in 2020 filed suit against two homes associations regarding racially restrictive language contained in the associations' deed restrictions. To my knowledge, these restrictions were created by the original developers of our neighborhoods and date back to the early 1900s. Our district's deed restrictions are similar to those of the other home associations who were contacted by the AG. The deeds contain some very odd and outdated things, including restrictions based on race and religion. Although our association was not contacted by the AG's office, our board determined we should formally remove restrictions based on race and religion.

A review of our deed restrictions showed the CCDHA Board of Directors made an effort to remove some restrictions almost two decades ago. The board repealed the racially restrictive covenants pursuant to a statute passed by the Missouri Legislature in 2005. However, we learned that the action taken in 2005 was not sufficient, as a document needed to be filed with the Jackson County Recorder of Deeds to record the removal of the restrictions from the County's land records. We engaged legal counsel to draft a deed amendment for our association and make the necessary filings. To produce a valid document, our counsel, Rod Hoffman of Martin Pringle, researched the group of plats in our district to create an exhibit for the filing that legally identifies all the properties within our borders. We thank Mr. Hoffman for his effective and efficient work. Earlier this year, our board approved the amendment. The filing removing restrictive covenants based on race or religion in our district is now on file with the County's recorder of deeds. If you have any questions, please feel free to reach out to me.

The board is looking forward to visiting with you all at the return of our annual social event (August 22nd) and welcome a hybrid-style (i.e. online/ in-person) annual meeting in September to deliver a full report on our activities. Please feel free to reach out to me or any other board member if we can be of service—or perhaps you would like to be of service by volunteering?
