# **Recycling Works: Ripple Glass**

Last year alone, Kansas Citians threw away 150 million pounds of perfectly good glass. To the dismay of the people at Boulevard Brewing Company, this included some 10 million empty Boulevard bottles – lost forever, buried in local landfills.

# Kansas City recycles only about 5% of its glass. The average rate in the United States is nearly 30%.

Kansas City businesses use nearly 100 million pounds of recycled glass every year (brought in from hundreds of miles away), so why almost no local recycling? Because there was no nearby facility to process the glass. And why no local processor? Because, in classic chicken-and-egg fashion, there was almost no local recycling.

The folks at Boulevard finally got tired of being part of the problem. So, with the support of local companies and community organizations, they came up with a solution – **Ripple Glass**.

Ripple has constructed a state-of-theart processing plant right here in KC, and placed dedicated glass recycling containers throughout the metro area. Best of all, Boulevard found a local customer that will



convert the recycled glass into fiberglass insulation, saving enormous amounts of energy and dramatically lowering emissions while producing a product that saves still more energy.

It's a great way to close the loop, protect the environment, support local businesses and even make homes more energy efficient.

But it will only work if you get involved. Help give glass a second chance.

You will find two purple Ripple Glass bins on the northwest side of the 51st Street & Main corner just to the north of our homes association. And one south, at Berbiglia on 63rd in Brookside. Note: For safety reasons, do not leave glass on the ground near the containers. If full, be patient and wait for the bin to be emptied.

## Reminder: Fireworks not allowed in Kansas City – Chief James Corwin, KCPD

INDEPENDENCE DAY IS COMING UP soon, so it's time to remind the residents of Kansas City, Mo., that fireworks are prohibited in city limits. City Ordinance 26-3309.I states, "Except as hereinafter provided, it shall be unlawful for any person to possess, keep, offer for sale, sell at retail, use or explode any fireworks in the city."

The exception stated in that code is for permitted, professional, public displays, of which there will be several for you to enjoy.

There is a very good reason the city does not allow the personal use of these explosives. Last year, KCPD responded to two fireworks casualties. One involved a young adult who lost at least one finger. In the other, an adult taped several powerful explosives together and threw them into the air while they were lit. They came apart, and one fell down and hit an 8-year-old child in the face. The boy lost

sight in one eye, and his ear drum burst, which could leave him with permanent hearing loss. He also will likely have scarring from the burns.

In 2008, the Kansas City Fire
Department reported that it responded
to II fireworks-related incidents. Ten of
them were between June 29 and July 9.
One caused \$400,000 in damage. Several
people lost \$25,000 worth of property
from fires caused by fireworks. These
happened in all kinds of areas – occupied
and vacant homes and apartments,
detached garages and in open spaces.

Even seemingly innocent things like sparklers can have huge consequences. They burn at 1,200 degrees Fahrenheit, which is about six times as hot as the temperature needed to boil water. That can cause serious third-degree burns.
