to keep both you and others safe and out of the hospital:

- Always have winter weather salt treatment on hand before snow and ice arrive.
- If you live in an area that receives a lot of foot traffic, clear your sidewalks as soon as possible.
- Even if you're out of town, you're responsible for removing ice and snow. Make arrangements to have someone do it for you while you're away.
- Shovel and treat your sidewalks, walkways, and driveways quickly and before too much snow or ice accumulates. A snow blower is great for handling most of the hard labor for larger amounts of snow.
- Be sure to check downspouts. Snow and ice can melt and drain out of gutters and freeze later, forming icy patches and dangerous icicles.
- Place mats with tread on your doorstep and inside your entryway, so that guests and visitors can dry their shoes. This will help prevent slippery surfaces in your home and avoid injuries and hospital visits.
- Always keep an eye out for potential tripping hazards, and make sure the areas around sidewalks, driveways, and walkways are well lit.
