
Crestwood 2011

Annual assessment billings have been mailed. About 2/3 have paid their 2011 assessments. A few may have forgotten and have not paid last year's assessment. I encourage you to catch up. HA-KC recommends placing a legal lien on the property if timely payment is not made for 2 years. This costs you an additional \$100 in legal fees and we do not want to do this. Please help us avoid this cost. Where does the money go? While our assessments in these challenging economic times may seem large or even exorbitant, the pie chart at the right shows the major expenditures (detailed if over \$1000). Crestwood is unique to the area with our common access parks and our islands and entrance monuments. These

are the responsibility of CHA
Board to maintain. In recent years, as requested by residents, a lot of effort has gone into improving the level and quality of the way the com-

mon areas are maintained. This year's 2011 budget for expenditures is the same as the expected income. The budget is for expected expenses. The current reserves (\$24,000) are for the unexpected expenses such as storm damage to trees,

removing dead trees, more than expected snow etc.. The 2011 budgeted expenses are matched exactly with the \$36,000 expected income. The adopted budget will be on our web site in February 7 board meeting minutes.

PIAC/funding

Requests made for 2011 for CHA master plan goals for monuments at 56th Oak and at 54th and Oak were denied for this year. Emphasis is being placed on infrastructure needs in neighborhoods and

not new projects. John Crawford will resubmit the requests for next year. We have been fortunate for the assistance we have had in the past. PIAC funds paid for most of the monument and island work done fulfilling the CHA master plan.

UMKC/Cherry Street Parking Structure is scheduled to

be torn down beginning in May. This is one of three bond funded projects approved for UMKC. This will make for some challenging times in terms of parking. The current structure allows for parking of about 700 cars. Constructing a new structure is anticipated to take about a year. When completed it will provide parking for twice as many cars. The other two projects are providing additional class room space by adding on to the library, and renovation of the old union to a student success center.
