A Letter from the President...

Happy summer Neighbors! It was generally a mild winter and a beautiful spring, which is always nice for the neighborhood's pocketbook as we spent very little plowing our streets. We decided to celebrate that savings and use a few of those dollars to resume our annual meet and greet at RC's last month. Thank you to all who joined us! I believe a good time was had by all, and it was a pleasure to see many familiar faces and meet some new folks!

Speaking of get togethers, thanks also to all who came out for Easter Egg hunt. We loved seeing so many children and families out at the park. We are excited to see many more enjoying all the new improvements to the park that were completed last fall!

While we are of course blessed with such a lovely park, some of the sidewalks to get there can be a little treacherous and are getting worse with the passing years. Last year we applied for curb and sidewalk replacements and improvements through Rebuild KC grant program, which is tied to the \$800 million in GO bonds approved in 2017 by voters to be funded over the next 20 years through increased tax revenue. \$150 million of those funds were subsequently earmarked for sidewalks after a study was completed estimating the need. We received notification that our request for funding was not accepted. That might have been a bummer if we didn't keep reading and found out that a duplicate request had been submitted and approved for funding! Unfortunately, we do not have a timeframe for all these improvements, but it has been nice to see the city starting to address some of our curbs and sidewalks throughout the neighborhood. It does give us hope for the future on a project whose scope frankly exceeds our resources.

Speaking of things out of our control but of interest, there was some unease and consternation brought to our attention regarding the improvements to Barstow. Several board members attended a community meeting at the Center Planning and Development Council in March where Barstow presented their plans. While we did not get much of a feel for the impact to our residents during the meeting, I followed up afterwards with the President of Barstow. He assured me they have our neighbors in mind and are confident their improvements would have no negative impact. He indicated he is happy to have a conversation with individual neighbors to address any concerns should they have them.

COMMON AREAS: Sprucing Up Our Outdoor Areas for Summer

With the drought we experienced last year, there are a number of dead and dying bushes. The company is working on a bid to remove and replace those, in line with our commitment to maintain the beauty of our neighborhood. We also plan to have all our monuments washed and sealed again this year to make them shine!

We have been very happy with the change in our landscaping vendor thus far, but please let us know if you see islands on your street or other common areas that need attention. We welcome your feedback! We also welcome your involvement as a volunteer during future workdays around the neighborhood or as a future board member taking a special interest in keeping our common areas looking clean and beautiful for all residents and guests of Verona Hills.

PUBLIC WORKS: Sidewalks, Streets, and More

Although sidewalks are technically homeowner property, we have decided as a board that, at the very minimum, we want to invest our time and energy into seeking sources of funding for improvement to our sidewalks. Last year, we applied for PIAC funds like those that have been used at the park. We also applied for funds through the Rebuild KC Neighborhood Grant Program through the city, which has been put in place specifically to fund such projects to improve city neighborhoods. As you read in the President's letter on the first page of this issue, we were notified that one of our funding requests was approved with more details to come!

Meanwhile, the city has been working on several curb and sidewalk replacements in the neighborhood. You might have noticed some repairs taking place along Minor Drive. The city is committed to addressing these issues – but what we can do is be a squeaky wheel and report any curb, sidewalk or pothole problems to the city, either through their [KCMO website](#) or by calling 311.

HEARTLAND TREE ALLIANCE: Sign Up for a Free Tree

Several years ago, the Heartland Tree Alliance, in partnership with the city, made an offer to any interested Verona Hills resident to plant a free tree in the easement area where trees had died. Many of you took advantage of this opportunity. Since then, several residents have reached out with additional interest in receiving a free tree. At this time, we are told they are not currently targeting our specific neighborhood.

However, in a discussion with one of their reps, they indicated that if enough neighbors request a tree and sign a pledge form to water a tree planted in their yard, they will make arrangements to make it happen for us! COMPLIANCE CORNER: City Guidelines for Trash Pick-Up

We frequently receive inquiries from neighbors asking what types of trash and waste can be placed outside for trash collection, and what to do with trash that exceeds that two-bag limit. The City provides trash service to our neighborhood and has restrictions on what trash it will pick up.

According to the City, the following materials will be picked up on trash day:

- Food waste and packaging
- Small appliances, toys and tools
- Rubbish associated with normal home maintenance
- Small automobile parts that can be bagged, such as spark plugs, brake shoes and shock absorbers
- Building materials bundled with twine or wire, including wood and wood products, plaster or wallboard
- Boxes of shingles, empty paint cans and similar small items generated during routine maintenance and minor home repair

The City will not pick up any of the following:

- Yard waste, including grass and other clippings, leaves and brush
- Non-hazardous liquids (e.g., soft drinks, water, juice, etc.)
- Hazardous materials
- Sharp items
- Car batteries
- Glass
- Items weighing more than 40 pounds
- Items longer than four feet in length
- Animal excrement unless double bagged

Each household may put out two bags of trash for collection each week. If you have more than two bags of trash, you can purchase trash tags for \$2.50 each that allow you to set out additional bags. These tags can be purchased at Price Chopper and Westlake Ace Hardware.

Twice per year, the City also grants a trash amnesty where residents can put out up to 12 bags of trash without additional tags, so long as each bag weighs less than 40 pounds. These two trash amnesty days typically follow Christmas and July 4.

Wanting to Raise Chickens? You're Clucking Up the Wrong Tree.



We have recently had several inquiries and incidents of chickens in neighbors' yards. Unfortunately, this is an activity that is expressly restricted in the Declaration of Restrictions for the neighborhood in Section 14. Livestock and Poultry Prohibited. As you all know, the various formative and governing documents of our neighborhood represent a legal contract between the HOA and its homeowners. As a board of directors, we are charged with adhering to these documents on behalf of and in the best interest of the neighborhood. A request for an exception for poultry activity has periodically been presented over the past number of years. There has never been support to grant an exception. Further, given the overwhelming resistance to poultry related activity in discussions with neighbors and board members, there has been no support to take any action to attempt to modify the Declaration of Restrictions for poultry related activity.

Outside of our requirement to adhere to the restriction detailed above, in the theoretical absence of the restriction, or for instance in a different neighborhood where the restriction does not exist, we can certainly see the appeal of keeping chickens for a number of reasons. However, from the perspective of a neighbor, voiced concerns have included the noise, the smell, and the possibility of attracting rodents and predators that could be dangerous for pets and small children. In addition, having a neighbor with chickens could potentially detract from the marketability and therefore diminish the value of one of your neighbor's homes, as knowledge of a neighboring chicken coop would very likely limit the number of interested buyers.

Prior to commencing any project, we strongly recommend looking up any city ordinances and referencing our covenants and restrictions. Please do not hesitate to reach out with any questions or concerns.

TREASURER'S REPORT: Annual Dues and Liens Collected



Our fiscal year runs from June 1 through May 31, with annual assessment of \$150 due by June 30 each year. Our assessments have not been raised for many years, and they are meant to be affordable for all our residents. Please make sure to pay your assessments on time. They allow us to enjoy many of the core services you have come to expect and are highlighted in this newsletter, as well as continue to evaluate other services and events for the benefit of our neighborhood.

Did you know you can pay your dues online? Go to our website, www.veronahills.org, and our online payment portal is front and center! You will be able to make a one-time payment or set it up on auto debit going forward. You will only need your account number which can be found on your dues statement, or by calling our management company Homes Associations of Kansas City at 913-385-2440.

We have a collection policy in place that includes filing liens on properties once they become due for a third year on their assessments. Once a lien is filed, not only are individuals being invoiced for past due assessments, but also interest is added at 8% on the balance, and legal expenses incurred by the Association are included. Once an assessment is over four years past due, we are obligated by our Homes Association Declaration to file suit to collect

the delinquent assessments. This action increases expenses, including legal, filing fees and court costs, which are added to the delinquent assessment amount. The cost to file a lien is approximately \$100, and the average expense if an account goes to trial is over \$1,000.

In addition, a filed lien or judgment may have negative consequences on your credit rating. Overall, your Board of Directors would rather spend our volunteer time (and your hard-earned money!) providing services and improving the neighborhood, rather than exhaust the time and money collecting delinquent accounts. Further, it is not fair to the homeowners who pay when the assessments are due.

Our cash flow statement for the fiscal year ended May 31, 2023, is on our website. As a board we can confidently say our neighborhood remains in strong financial standing, with ample reserves to position us to address any unforeseen problems, continue to keep our streets safe from inclement weather, and further invest in our neighborhood. SECURITY UPDATE: Statistics & Safety of Our Neighborhood



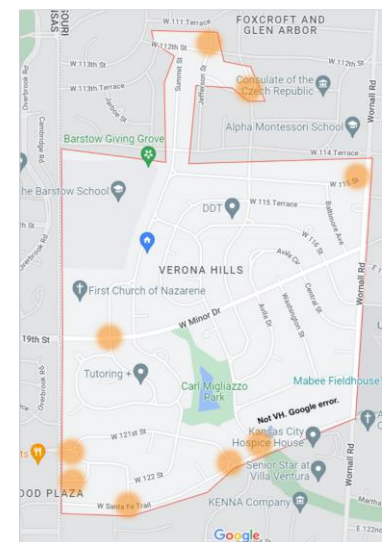
Great news! Since our last newsletter, REPORTED crimes have significantly gone down. Recently, we were able to help solve a stolen vehicle crime by using footage gathered from the cameras we've been installing!

While we've had several personal calls and concerns about suspicious folks in the area, we please ask that if you feel in danger, call 911 immediately. If you just want to report a nuisance individual and don't need immediate attention, it's best to call the South Patrol non-emergency number at 816-234-5550, option 4. The best way to prevent criminal activity is to reduce opportunities by keeping garage doors closed, doggie doors protected, your home well-lit, and your vehicles and home securely locked. If you need to request additional patrols in a specific area, you can request that online at www.kcpd.org.

Crime stats can be found via kcpd.org or cityprotect.com. It's a great resource to monitor how we are doing relative to surrounding communities. We will also stay in touch with the South Patrol on a regular basis for future updates.

Since our last newsletter, we have added an additional 4 cameras in the neighborhood. If you already have surveillance cameras on your home, please register with WatchKC so you can be a part of the solution to crime in our city. If you should experience any type of crime, please feel free to reach out and we will look through the footage and pass along to South Patrol for their review.

Did You Know: New Santa Fe Is a Historic Part of Verona Hills

New Santa Fe, Missouri, was a little village incorporated in 1852 just north of the Old Santa Fe Trail and east of the Missouri State Line in South Kansas City, an area now known as Verona Hills. Historian Gregory M. Franzwa wrote, "New Santa Fe was the last civilization the early traders would see before arriving at the settlements in New Mexico." For a while, the town stood at the edge of the geographical United States, bordering only on Indian Territory.

The village developed about the farm of John Bartleston, who erected a cabin in the forest along the Santa Fe Trail in 1833 and subsisted on hominy and potatoes. Dabney Lipscomb and his wife, Elizabeth W. Lipscomb, "laid out" the town on October 5th, 1851.

Several hundred families lived in the area. There was a post office located in the general store, blacksmith shops, saloons, a few other small businesses, and an inn. A few area settlers became well-known historically. Jim Bridger and George W. Kemper, both familiar names in Kansas City history, built one of the original stores in the town. William S. Gregory, a wholesale grocer who lived at New Santa Fe, became the first elected mayor of Kansas City.

Being a border town was a mixed blessing. The village suffered from the Border-Ruffian war of 1855-56. Quantrill's guerrillas also raided the town. In 1861, a Civil War battle nearby took the lives of two Union soldiers and wounded six. Confederate General Sterling Price's wagon train plus Union Generals Curtis and Pleasonton and their troops camped there.

As railroads began to replace wagons for hauling freight and trade merchandise, the Santa Fe Trail was used less frequently and commerce in the town decreased. In 1902, the government closed the post office.

The Daughters of the American Revolution placed a marker at the northeast corner of Santa Fe Trail and State Line Road in 1909 to commemorate the town, which still remains. By 1932, only a few scattered dwellings remained along the roadway. In 1952, former residents gathered to celebrate the hundredth anniversary of the town of New Santa Fe.

The community is enveloped in Verona Hills, at about 123rd Street between State Line and Wornall Roads. About a quarter of a mile away still stands the Watson Place Inn, built in 1850, where drinks were served to travelers "on the Missouri side." It is now a private home.

On April 28th, 1977, the Historical Society of New Santa Fe was established to preserve and memorialize the history of the town and the surrounding region. This group was instrumental in preventing a development by J.C. Nichols of a grocery store anchored shopping center that would have backed up to the cemetery of New Santa Fe. Today over 50 Verona Hills homes stand opposite the closed Hy-Vee / new Barstow IDEA Space as a result of these efforts.

The National Park Service certified the trail rut in New Santa Fe Cemetery, located on Santa Fe Trail one block east of State Line Road, as part of the officially mapped National Historic Trail System. In the 1980s, the Howard N. Monnett Memorial Civil War Round Table Kansas City erected a monument (Tour Stop 22 of 23). It was donated by the Historical Society of New Santa Fe. In the 1990s, the Kansas City Neighborhood Tourist Development Fund (NTDF) approved the application to install approximately 700 ft. of custom designed wrought iron fencing and an arched entryway at a cost of \$28,000. On April 11, 2000, a beautiful full color wayside exhibit depicting the Santa Fe, Oregon and California Historic Trails was dedicated through the efforts of the Historical Society in conjunction with

the National Park Service; Department of the Interior; Long Distance Trails Group Office; Santa Fe, New Mexico; and the Kansas City, Missouri Neighborhood Tourist Development Fund.

The cemetery is now owned by the New Santa Fe Cemetery Association, a nonprofit organization which has the financial responsibility for the upkeep of the cemetery. Thanks to contributions in 2014 and two Eagle Scout projects by St. Thomas More's Troop 601 and St. Peters' Troop 46, headstones were repaired, cleaned and reset. A flag pole, two Santa Fe Trail limestone markers, and a new entrance were also installed.

If you haven't visited the cemetery recently, please do. It's an interesting piece of history just yards from your door. In fact, it is listed in the National Register of Historic Places!

As a neighborhood, Verona Hills makes a small donation annually to support the beautification and maintenance of this special area. It is one of the many jewels of our community.
