# **Notes From Your Board President**

### Happy New Year!

I hope 2022 was a good year for you and your family. The board and associated committees will be busy in 2023 helping to keep our neighborhood looking great, planning events to provide fun activities for all,

and managing such amenities as our pool, pond and trail system.

There are two payment options for Northwood Trails 2023 dues, which are \$575.

1) Pay balance in full by Feb. 1 and deduct 5% (28.75).

2) Pay half of balance due by March 1 and pay remaining balance by May 1. A \$50 penalty will be added to any unpaid balance as of June 1.

Take a moment to think about volunteer service and the committees that handle the tasks that keep Northwood Trails special. I know everyone has a few moments here and there that they would be able to put towards volunteering in the neighborhood. Just think what we could do as a neighborhood if all 459 homes spent a few minutes a month to volunteer.

### **From The Treasurer** *Bryan Kelling*

Northwood Trails Homes Association membership dues for 2023 increased \$75 to \$575. It was the first dues increase in five years.

Please know this increase was not undertaken lightly. The convergence of economic issues facing the United States with the current budgetary needs of our Homes Association led our board to vote yes on the 15% increase.

Labor costs have increased for the contractors who handle our pool, grounds and irrigation needs. Costs have increased across the board for supplies such as fertilizer for the common areas, the chemicals used to keep our pool clean and up to code and the inputs that keep our pond from being overtaken with algae.

At the same time, the board in 2022 began to address several maintenance issues that had been deferred from previous years. Examples include removal of dead trees and limbs in common areas and replacement of broken, unsafe furniture at the pool. Continuing to address such matters in 2023 in order to maintain the amenities of our unique community meant budgeting for price increases thought to persist into the foreseeable future.

Finally, it was the board's intent to notify everyone of this increase in the January newsletter ahead of notices going out. This unfortunately did not happen. While I had no control over the timing of the notices going out, I would like to apologize for this happening. eNeighbors.com

As a critical step in the planning process for home improvements and modifications, take a look at Nos. 5-20 of the Declaration of Restrictions of Northwood Trails, which limits use of your property and modification to your dwelling. The document is presented at the closing of an NWT property sale, but is always available at the Northwood Trails page on eNeighbors. Just click on the Documents tab at the top. Under the Legal Documents section, click on Deed Restrictions.

Annual meeting: Thank you to all the Homes Association members who were represented at the annual meeting Nov. 15 at Grace UMC. Homeowners represented either in person or by proxy numbered 69 out of 459 households and it was a struggle prior to the meeting to obtain a few more proxies in order for the meeting to proceed. NWT bylaws stipulate a quorum of 68 households (15% of membership) must be represented in order to conduct the annual meeting. While your volunteer board members understand that everyone is busy, we'd like to ask in 2023 and beyond that HOA members give more thought to being represented at the annual meeting. Meetings normally take 30 minutes or less, a minimal commitment to attend in person. Or, you you can always send your proxy with a neighbor or deliver in advance to a board members

**Community mediation:** In a perfect world, we'd all get along famously. In the real world, neighbors at times have disagreements. NWT board members are sometimes asked "What can the board do about it?" Unless the root cause of the disagreement is something governed by NWT bylaws or deed restrictions, there is not a whole lot the board can

do. If talking with your neighbor doesn't work, the City of Olathe offers community mediation as mentioned in the Winter 2023 *Olathe Link*.
