# **Pond Committee News**

Spring has sprung, and the trails surrounding the pond find more and more residents each day. Those who prefer a serene scene usually walk between sunrise and 9:30 when the twin aerator fountains automatically activate. The aerators help keep the water circulating to avoid stagnation but add pleasant noise and an eye-catching aesthetic to your stroll.

For worry-free fountain operation and maintenance, we have original Northwood Trails homeowner Keith Read to thank. His donates time and expertise that saves about \$600 every year.

The aerators work with the numerous inputs designed to eliminate algae on the pond bottom and water surface and clarify the water. Chairman Emeritus Pat Madden, a 19-year resident, handles the logistics of these inputs, works to tamp down weeds along the shoreline, and supervises a crew (including navigator Max Mueller) that climbs aboard our dinghy tri-weekly during the summer to treat the pond.

On April 24, a pond committee crew completed the following improvements:

• Mulched the permanent amenities of the west-side picnic area: three tables (recently power-washed/ stained), two charcoal grills and a garbage can.

• Cleaned out and mulched the bench and bed of plants and flowers on the northwest corner, and trimmed back the tree overhead.

• Cleared brush and Osage hedge ball saplings that had encroached the southwest corner path.

• Leveled the flagstone fishing rocks along the north shore and filled a major sinkhole under one.

• Filled the north shore ground depressions and seeded the dirt.

• Rebuilt, leveled and backfilled three paving-stone landscape walls along the north shore.

Many thanks for their sweat and toil go to the volunteer crew: Jim Buehler, Ken Gandy, Jason Hrabe, Pat Madden, Matt Noltemeyer, Keith Read, Kathy and Orin Swift, Luke Weber, and Tony Wittman.

The Pond Committee's focus now turns to planning the annual Fishing Derby with the Social Committee. Volunteers are welcome, and needed, so if you are interested, email MattNoltemeyer@gmail.com.

Recommendations/best practices for fence construction:

- 1. Along with you architectural request, submit a map/sketch with dimensions of the sides/back.
- 2. A survey guarantees correct placement ask your fence company if they provide one.
- The next best thing to a survey is a written agreement about property lines from neighbors.
- 4. When sharing a fence line and tying into the neighbor's fence, a written agreement is also important.
- 5. Privacy fences block views and breezes please consider why one is necessary and discuss the fence with all adjacent neighbors.


