LETTER FROM THE VICE PRESIDENT.....

Don't underestimate the power of the people!

A handful of years ago many home owners and the board agreed that draining and dredging the pond in Migliazzo Park was a good idea. I don't know if it has ever been done. Certainly, not in the past 30 years, according to neighbors. We agreed that it was important not only from an aesthetics standpoint, but from a safety one, as well. The moss/sledge/muck had gotten so thick, it became a concern that kids wading into the water may fall face-flat, unable to escape. Many attempts to convince the City were made by the board and neighbors. PIAC requests were presented. Safety concerns were raised. Many people suggested it was important enough that Verona Hills should pay for it themselves. A cost estimated by the board as way too high. As the years passed, and the no-answer was continually received, the home-owners seemed to be that much more determined than deterred. Finally, we received confirmation earlier this spring that the project was approved. However, the removal of the island was not included. At the risk of "looking a gift horse in the mouth", we again continued to press for the removal of the island. It was deemed both an eyesore, as well as a haven for the geese. Finally, we were informed that the island portion of the project would be included.

My thoughts are that, it is great to see the pond drained and dredged. No question. What is greater is seeing residents take so much pride in their neighborhood, they won't take no for an answer. Everyone understood that, technically, the park is owned by the city. But, realistically, it belongs to the neighbors. Next up, geese beware...

Finances

Finance Update

As we begin a new fiscal year, the Board has been working hard to ensure we have a balanced budget with a cushion for unexpected expenditures. Our mission in setting the budget focuses on two goals. One is to keep Verona Hills as well maintained and safe as possible to ensure continuance of the property values we enjoy. And the second is to provide opportunities to gather as a neighborhood to continually replenish and expand the wonderful sense of community we have. Based on these goals, our major categories of expenditure are 1) common area maintenance and replenishment 2) snow removal 3) neighborhood activities and 4) additional security for the neighborhood. These items account for about 85% of the expenditure against our yearly dues collections of roughly \$112,000.

At the Fiscal Year Ending (FYE) May 31, 2007 our balance sheet was showing approximately \$73,000 in reserves, with \$27,000 in liabilities. Our total expenditures for the FYE 5/31/07 was \$163,000. Quarterly updates will be provided in the newsletters go forward and at the Annual Meeting in November. Please contact Cindy Sullivan if you have questions, comments or concerns regarding our Finances.

Liens Filed

We have 16 extremely delinquent homeowners who haven't paid their annual dues for over a year. Balances owed range from \$242 to \$1,116, for a total of about \$10,000. There are about 76 of our 750 homes that have not paid their current years dues, which were due on June 30th. If these amounts are not paid by August 30th, liens will be filed against the

properties and addresses published in the next newsletter. You will know if you are one of these 76 homeowners if you have continued to receive reminder invoices for payment. If it seems like we are being heavy handed on this, we are as we represent the 674 homeowners who have met their obligation and paid their bill on time without needing multiple reminders.

Annual Garage Sale and Reminder from our Local Law Enforcement

Don't forget to join in the fun of the Verona Hills Annual Garage Sale coming September 7th and 8th! And just a reminder – as with all things that involve monetary transactions – be aware of what is going on at your sale. Last year there were several reports of counterfeit bills being passed at the VH garage sales. Usually \$20 bills, but some \$50s and \$100s. According to our local police officers, the passing of counterfeit bills isn't all that rare, but still not really something that is common. With the availability of textured papers and the quality of home scanners and printers, it is possible to produce some fairly good facsimiles of real currency.

Here is what to watch out for. The "paperhangers", as they are known to police, usually wait until a garage sale is busy, then select several relatively high-ticket items and pay with the large counterfeit bills. They not only make off with the merchandise, but many times some of your hard earned cash when you make change for them.

If you think you have taken a counterfeit bill, or if someone at your garage sale is acting suspicious, please call 911 immediately to report. Remember that even passing a small counterfeit bill is a federal offense. As well, we have talked with South Patrol to let them know our Garage Sale dates so that they can increase patrols as appropriate.

The first Annual 1K/5K Kansas City Walk for Awareness will be held on September 15, 2007 at Migliazzo Park. The Walk for Awareness is a one-day event to generate awareness about psoriasis and psoriatic arthritis and to raise money for National Psoriasis Foundation education, advocacy and research programs. The Walk will take place on streets through Verona Hills. Please see the route below:



Walk begins at the intersection of Pennsylvania and Glen Arbor Terrace, South on Pennsylvania, East on 119th Terrace, North on Washington, West on Minor, North on Glen Arbor, West on 114th Terrace, South on Summit, South on Madison, East on W. Santa Fe Trail, North on Pennsylvania, Walk ends at intersection of Pennsylvania and Glen Arbor Terrace

Many myths and misconceptions surround psoriasis and the need for awareness is great. Psoriasis is a noncontagious, chronic skin disease that causes red, scaly patches, which can appear on any part of the body. Psoriasis on the hands or feet can prevent people from doing everyday tasks such as writing or walking. 10% to 30% of people with psoriasis may also develop psoriatic arthritis, which causes pain, stiffness and swelling in and around the joints. According to the National Institutes of Health, psoriasis affects as many as 7.5 million Americans.

Public Hearing: Amending the Bannister Mall Area TIF Plan

The second amendment to the Three Trails District Tax Increment Financing plan will be heard September 12th at 9:30 a.m. at the Tax Increment Financing Commission of Kansas City MO, 1100 Walnut, Suite 1700, KCMO. (This is public hearing in regards to redevelopment of the Bannister Mall site known as the Three Trails District Tax Increment Financing Plan.) The proposed second amendment provides for:

- (1) the modification of the Redevelopment Area to include the area highlighted on the map on file at the Commission office;
- (2)demolition of Bannister Mall;
- (3) demolition of the retail shops on the east and west of Hillcrest Road commonly known as Benjamin Plaza Shopping Center, excluding some of the existing out parcel buildings on the east and west sides of Hillcrest Road (on the west side, the new fire station and cosmetology school are to remain);
- (4) demolition of two hotels on the south side of 87th Street;
- (5) demolition of selected buildings on the south side of Bannister Road;
- (6) renovation one 100 room hotel on the north side of 87th Street;
- (7) construction of up to 1,061,850 square feet of retail space;
- (8) construction of an up to 250 room 160,000 square foot Stadium hotel;
- (9) construction of a 17,000 22,000 seat multipurpose facility and 12-18 tournament soccer fields;
- (10) construction of up to 1, 614,500 square feet of office/mixed use office; (11) construction of public recreation areas;
- (12) construction of all necessary public infrastructure;
- (13) cost benefit revisions;
- (14) updated employment and construction information; and revisions to Redevelopment Projects Costs budget.

The intention of the plan remains unchanged other than those changes specifically mentioned herein. The Redevelopment Area is generally bounded by 87th Street on the north, the Kansas City Southern Railroad tracks on the east; Bannister Road on the South and Interstate 435 on the west in Kansas City Jackson County Missouri. The Amendment as proposed may be reviewed by any interested party on or after September 5, 2007 between the hours of 9:00 a.m. and 5:00 p.m. at the offices of the Tax Increment Financing Commission, Town Pavilion, 1100 Walnut, Suite 1700, Kansas City Mo. According to Section 99.830.3 all interested parties will be given an opportunity to be heard at the public hearing.

Southland Hazardous Household Waste Drop-off

A South Kansas City Hazardous Household Waste event will be held at Hale Cook School, 7302 Pennsylvania from 8:00 - 12:00 on Saturday, September 8, 2007. We normally reach our maximum allowed limit of 200 cars bringing hazardous waste by 11:00, so coming early is best. Cars with only leaves, brush, tires and non-hazardous recycling will be accepted until the 12:00 deadline.

The event is only for those living in Kansas City, Missouri. Proof of residence is required. Please have it handy when you come to the event. The homes associations sponsoring this event are once again asking each participant to bring one can of food or one dollar to donate to Harvesters. All traffic coming to this event will enter the school property on Pennsylvania and exit on Jefferson. Cars may enter from either the north or south on Pennsylvania.

Materials will be accepted from residences only. Business waste is not accepted. If you can't buy an item at a store, it's probably not residential waste. Twenty gallon and 55 gallon drums are considered business waste and will not be accepted. No material in containers larger than 5 gallon buckets can be brought to this event.

For your reference-

Allowed Items:

Brake fluid, oil, antifreeze, gasoline, car batteries, household batteries, household cleaners, lawn and garden chemicals, expired medications, road flares, pool and spa chemicals, paint, leaves, brush, tires, paper, magazines, to name many.

Refused Items:

Explosives, needles, radioactive waste, smoke detectors, some cancer medicines, glass, oxygen tanks, Styrofoam, grass clippings.

Neighborhood Developments

Hump Day

After several years of diligent pursuit of an effective traffic calming solution for Santa Fe Trail, three speed humps were installed on July 27. Residents of Santa Fe Trail report they have been very effective in reducing the speed and volume of traffic on the street. Thanks go to our 6th District Councilpersons for supporting the wishes of neighborhood residents.

<u>Santa Fe Trail Widening</u>

Construction plans are approved and ready to go out for bid on the widening and improvements to Santa Fe Trail between Wornall and Pennsylvania. The project is on hold at the present time pending resolution of right-of-way issues with residents along the roadway. Hopefully, work will proceed this fall.

Vandalism

Recently we have had costly damage done to homes and cars in the neighborhood by items such as eggs, shaving cream, mustard, ketchup, maple syrup, flour and last but not least toilet paper (wonder if any of these items are missing from your pantry?). We are not sure who is behind the activity at this time, but we have contacted South Police Patrol and our off-duty police officers to make them aware of the problems we are having. We want to reiterate that the offenders will be prosecuted when caught, and full restitution will be expected.

Common Area Tree Trimming and Island Maintenance

For the third season, Family Farm Landscaping has been awarded the contract to maintain the common areas and islands. There are 41 islands and common areas that are inside Verona Hills. If you notice a common area or island that requires more attention, call Matt Ungashick. Please be mindful that Family Farms is not contracted to poop-scoop the islands. As our neighbors have become more cognizant to disallowing their pets to soil other residents yard while walking, please remember that the islands are **not** Free-Poop Zones. Please carry a bag with you while walking your pet.

Monument Update

Over the past two years we have been working hard to replace the major entrance monuments to Verona Hills. To date we have replaced the three large monuments on Minor Drive, and two smaller ones at $121^{\rm st}$ on the State Line side of the neighborhood. This year our plan is to completely finish the new monuments with lighting and potentially irrigation. We are looking into the cost of both and how that impacts our budget. Looking forward, our next steps will be to begin replacement of the seven remaining smaller monuments along Wornall Road, and then to look at additional points within the neighborhood that would benefit from having a monument to designate them as part of Verona Hills. One along Santa

Fe Trail would seem to make sense, let us know if there are other placements that should be considered.

Park Lake Dredging

The draining and dredging of the Migliazzo lake is finally complete!! The island has been removed to discourage the goose population, the aerator will be put in place next Spring to help keep the water from being too stagnant. Fish will be stocked to help slow the silt buildup. We feel very fortunate to have received about \$200,000 of infrastructure bond money to get this project completed, and give many thanks to our Southland Parks & Rec representatives for their efforts in making this happen! Now we just need to wait for the rains to come and fill the lake back up – here's to hoping that it happens soon!

Common Area Updates

We continue to look for common areas that are past their prime and need to be reinvigorated. We like to get the direct involvement of the homeowners around the common area to help with some basics when there are new plantings. Please Don't Feed the Geese in Migliazzo Park

As we look to improvements at Migliazzo Park lake, we kindly ask that you **please not feed the geese**. Over the years the geese have been very destructive, including tearing up the grass, leaving unwanted deposits on the sidewalks and playground and actually charging young children. We have worked with the City over the past four to five years to keep our goose population under control and we simply ask your help in not undoing the work that has been done. The geese in our Park have no natural predators in that particular environment. Left unchecked we could have a real mess on our hands to say the least. We know it is a fun outing with the grandkids or kids to hike down to Migliazzo Park and feed the geese, but please help us make the park enjoyable for all by refraining from giving the geese even more reasons to stay.

Historic Cemetery says "Cheese"

The New Santa Fe Cemetery located in Verona Hills recently was the subject of a photo documentary by Linda Lewis. Ms. Lewis took photographs of every stone in the cemetery and documented the name and location of each person interred. Lewis has done similar documentations for historic cemeteries throughout the area, and we are thrilled she chose to document the New Santa Fe Cemetery. Keeping your tree branches trimmed high off the ground not only is a good way to keep your home well-visible and safer from intruders, it makes it much nicer for walkers to traverse our sidewalks. Trim at least 8 feet high – you never know when our mayor might walk by.

No Sign Zones

To ensure that the entryways to our neighborhood look neat and well kept, we ask that you not place any type of long-term signage at or around the major entry points into Verona Hills.

Dear Sally,

This is a tough question. First, I'm not sure whether you are talking about the house itself, the lawn or both. Let's assume the worst. You've given me a couple of clues: first, if they are new neighbors, you might make a visit to welcome them to the neighborhood, and say that "as good neighbors, we want to offer you any help we can. We have a lot of yard tools that we can loan you to help you with your landscaping." If it's the house itself, mention in a friendly way that the neighborhood takes pride in the appearance of its properties, and if there's anything we as neighbors can do to help you, just let us know. Under more difficult circumstances, letters can be sent to the home owner from the homes association and in extreme situations the city will clean up the property and bill the owner.
