MONEY MATTERS

The VHHA income statement for August 2011 is included in this newsletter for your review. Larry Engel, VHHA Board Secretary/Treasurer, had the following comments: "After the cash shortfall in the last fiscal year we have taken steps to solidify our financial statements. First of all, we set aside \$5,000 in our budget to replenish our cash reserves. Secondly, we asked HAKC to change our income statements from an accrual basis to a cash basis so that assessment income is not reflected until it is received. Finally, we have established a \$13,840 contingency fund which will not be spent on special projects until we see how assessment income and certain expenses develop. The board is in the process of prioritizing the projects that need to be addressed this year, such as removing dead trees along State Line. We are interested in your input if there are projects that you would like to see addressed."

DAY IN COURT: ACTION TO COLLECT DELINQUENT DUES

This past Spring, faced with significant amount of accrued unpaid and delinquent Homes Association dues assessments, the Board of Directors decided that it was time to enforce payment of these accounts by appropriate legal action. The Declarations of the Homes Association not only gives the Board this authority, it actually *requires* the Board to take such action.

Accordingly, the Board unanimously voted to retain an attorney to file suits, obtain judgments and collect the ten most delinquent accounts. Lawsuits have been filed, and the majority of those were scheduled to be adjudicated in late August. Two of our neighbors have paid or have made arrangements for payment. We are hopeful that, when judgments are rendered in the other lawsuits, prompt payments will be made.

Past due assessments accrue late charges and interest, and judgments will also include attorneys fees and costs. Judgments are also liens against the real property, and thus constitute a cloud on the title which must be resolved before any sale or refinancing can take place.

While the Board regrets that such actions are necessary, it is simply not fair to those who pay their share on time to ignore those who don't.

The Board will always try to work with those who are experiencing difficulty paying their dues if they come forward with good faith reasonable effort to take care of their obligations. Please contact President Phil Paschang or any Board member to work out an acceptable payment arrangement.

VERONA HILLS PROPERTY VALUES

▶WHAT CAN I DO TO KEEP THE VALUE OF MY HOME AS HIGH AS POSSIBLE?

One of the casualties of today's uncertain economy is home values. The website Doughroller reviewed the top ten home value websites; Zillow, Real Estate ABC, and Eppraisal are listed as the top three. You can find sale prices of homes in our neighborhood as well as estimates of your home's value on these sites.

Articles on maintaining a high home value in the face of a rocky economy stress curb appeal – landscaping and regular external upkeep – as one of the most important factors. And, the articles also suggest that regular internal maintenance – simply fixing things as they break, patching holes in walls and repairing damage to floors as they occur, even when we're busy or broke, pays off when we may want to sell years later. Do a Google search on, "maintain home values" for the latest tips.

Your Homes Association contracts for snow removal to augment services provided by the City of Kansas City. Snow can be removed more effectively when cars are not parked on the street. Try to make it a practice not to park on the street, especially if snow is forecast.

IMPORTANT TRASH DATES

The next leaf and brush collections are both on Wednesday, November 16th and December 14th. Sacks and bundles should be curbside by 7 a.m. on that day. For the city's requirements for this pickup, or for more information, go to www.kcmo.org/trash.

Trash and recycling pickups will be delayed one day (moved from Wednesday to Thursday) after the following holidays: **Christmas Day** (observed) – December 26, 2011, **Martin Luther King Day** – January 16, 2012 and **Presidents Day** – February 20, 2012.


This year, speakers will include Kansas City elected representatives who will share their vision for Kansas City.
