2009 financial performance, 2010 budget

Despite the cost of snow removal at the end of 2009 our association finished the year with a small operating surplus. For 2010 there will be increased revenue and some increased expenses. With the additional cost of the snow removal after Jan. 1, the board projects the 2010 operations budget to be break-even with the final cost dependent on how much more snow we receive and Deffenbaugh's final pricing. The complete 2010 budget will be published in the next newsletter; meantime here's a summary:

Thanks for making the tough choice as a board to switch contracts...I feel less anxious about my ability to come and go during bad weather."
