**LAWN AND GROUNDS REPORT:** August Newsletter Editor Error: If you have branches overhanging electrical wires, call KCPL (not Overland Park).

John Rudzinski said there are several properties, especially along 119<sup>th</sup> terrace, that have tree branches that drag across the ground. Many have tree branches that push against or are growing over a neighbor's fence.

Owners are responsible for trimming those branches. Or preferably, "raise the canopy." That is, cut branches where they join the trunk of the tree so that the lowest branches are 6 feet above the ground. Our mowing crew will not mow under low-hanging branches. It's not safe for them to do so.

<u>Scoop your pet's poop! If you don't, your yard will not be mowed. No exceptions. That includes your front</u> and back yard. It is very unhealthy for the mowing crew to inhale poop particles that fly into the air, not to mention how unpleasant it is for them.
