# Approval of Minutes:

• Andrew moves to accept. Corey seconds. All present Board Members vote yes.

## Treasurer's Report - Corey Grace:

- Total Balance: \$69,403
- Account Payable: \$4,044
- Delinquent (not including Knapp Estate): \$20 (from someone on a payment plan)
- YTD: ~\$18,000 paid so far

# Lawn and Landscaping - Kelly Timson & Dale Williams:

- Lawn maintenance guys are only doing mowing at this point we'll keep that to a minimum based on the heat
- Another tree is dying so will have to "sort that out"
- Kelly received bid for Hadley culdesac
  - Zack's Lawn & Landscaping for Hadley culdesac: the only thing included is plants and planting the plants. He didn't put all details \$709.50
  - Goodwin (Bryson-possible crew supervisor) says they're only allowed to mow and do weed & feed in our neighborhood. Otherwise it has to be pre-approved to spray weeds in other islands. Ours is very minimal. This Spring Goodwin was instructed to only turn the mulch up instead of spreading new mulch. It showed white moldy underbelly, but that's what they were asked to do. Dale says "There was a HUGE discussion about the mulch." Steve Goodwin said told Dale there is way too much mulch on the islands and he suggested they just fluff it up instead of taking it out or adding new mulch. There is so much mulch now there will never be a chance for it to get thin.
    - Gave a bid for everything he thinks should be done. Over half is removing the rock and landscape fabric on the Hadley culdesac. \$4,005.52 in the bid.

- Recommends trimming the maple tree in the Hadley culdesac as it's getting overgrown: \$120
- Goodwin bid can be whittled down for line items
- Mears did not respond. Kelly will follow-up again.
- Wants to wait and see what the curb replacement looks like before going with any bids. Not totally sure curb will be replaced.
- Kelly will ask if the sidewalk construction people will remove the rock from the Hadley culdesac while they're moving the existing gravel pile.

## Communications - III Loxterman:

- Board members have assigned routes to pass out Directories. They are bagged in Ziploc bags, hole-punched and threaded with a rubberband so they can be hung from doorknobs.
- Jill will email and post on FB to expect delivery by Sunday at the latest.

  - C. Kelly says "Could we give something to homeowners instead of having a Block Party?" Dale says the block party is to meet people, not for the food.

  - E. Charles and Andrew are willing to be servers.
  - F. No bounce house, no face painting
  - G. Could ask for firetruck to come by; can set up washers or beanbag contest
  - H. Joe's KC does not deliver on Sunday
    - I. Would be a cold pick-up, have to be heated up at someone's house, no help setting up
    - II. \$13.95/person: beef and turkey with baked beans, coleslaw, and potato salad + utensils
      - (1) \$1,522.29 total bid based on 100 people

  - V. \$1,760 total bid-based on 100 people
