Recognition of Bill Malouche

Annexation of Homes

Five homes are platted for Indian Fields homes but are not part of our HOA. They are members of the neighborhood, but not the HOA. After discussion the board said we should just leave it as is, deeds would need to be rewritten, and legal fees would be involved. The board determined the addition of the homes would not add anything to the IFHOA and decided to leave the issue alone.

Leaf Removal Service

Tessie reported that the leaf removal service will only charge for homes where they have leaf removal. Leaves have to be 5 feet from curb; charge is about \$50 a house. Marti suggested the company would do homes that wanted to be done and charge the HOA. Then the HOA has to collect the fees. Would be great service but not everyone wants to participate.

Greg is going to a citywide (Ward #1) meeting tomorrow and said he will represent the HOA and express concern about leaf removal as a city service. Marti motioned and Alicia seconded the motion for Greg to represent us at Ward #1 meeting.
