Financials

Old Business

New Business

The board reviewed the list of board members and their term limits. Greg agreed to serve an additional term and it was the board's strong hope that Marti will agree to serve another term and also be board chairperson again.

The board discussed the 2018 picnic. We are looking at September 16th but decided to wait until the Chiefs schedule is issued. Most attendees want to look at other food options this year. Greg has a contact that does tacos; there was interest in pursuing them. Several people had face-painting contacts; the board wants to have tables/chairs and a tent again this year. Alicia is interested in working on the event and indicated Tessie is too.

Other Business

Greg inquired if we have D&O Insurance for board members. Cindy said she didn't know but would pursue and get copy of policy for board.

The board discussed the renovations at Homestead Country Club, specifically the drainage study currently being completed. The board felt strongly that they not get financially involved in any part of the situation. The HOA supports all neighbors but shouldn't get entwined in controversy.
