## **Communications** – no report

#### **Islands Committee**

Cheryl and Pat drove around with Dave from Canopy Landscaping for two hours and got the estimate for upcoming summer – estimate is within budget

- \$8K estimate is as expected
- Canopy sent invoice for half of the payment in advance. Cheryl and Pat told them HA-KC won't pay for work that hasn't been done.
- Today received unexpected bill for \$800 for clean-up. Reflects that Canopy is growing as a company and may not offer the same value they did when they were starting out.
   Cheryl and Pat expect to recommend staying with Canopy for this year and reviewing for next year.
- Included in \$8K budget is renovation of two large islands on Village Drive.

# **Diversity committee**

Earlier in the day, Ron had sent an extensive set of documents looking at the restrictive deeds of the PVHOA, including some original documents and articles summarizing the issue of people of color being excluded from home ownership in original PV HOA.

Ron attended the city's Diversity Committee meeting. Committee's plan for the year is to continue discussions on historical education and the need for diversity. Meeting was well attended.

# **Delinquent dues**

Discussion, led by Ron, focused on updating the current state of delinquencies and whether process of dealing with them should change.

- 37 homes owe \$50 and 17 homes owe at least \$100. There are some who owe large amounts, including a lien for \$1,500. Currently the total amount of dues owed is \$8,460.
- Historically those more than \$50 delinquent have received a form letter from HA-KC. If the amount owed is over \$250, a lien was put on the house. Cost is \$50 per lien. The amount of the lien includes the actual dues plus interest.

**Motion** – A motion was made by Ron that HA-KC is requested to send the standard letter to all those who are delinquent by \$50 or more. Shelby seconded and it passed.

# **Village Presbyterian Church donation**

Cheryl proposed the HOA make a donation to the Village Church for the use of the room and suggested \$100

**Motion** – Cheryl made a motion PVHOA donates \$100 to Village Church in appreciation of use of meeting room. Pat seconded and it passed.

#### Chicken committee

A house near Tomahawk Road reportedly has chickens. The owners may have started the application process but HOA has not received info that the application process has been completed. Ron will draft a letter to them asking them to go to HA-KC to complete process.
