With the summer heat behind us, you may be getting ready to tackle those outdoor projects you've been putting off. Remember that all changes to the exterior of your home or property must be reviewed and approved by the **Architecture Review Committee** PRIOR TO CONSTRUCTION or INSTALLATION.

If you are considering any exterior home or property changes, please consult the Declaration of Restrictions. Copies can be downloaded from the Blackthorne Estates website (Click Residential Documentation) or reach out to an ARC member (the member list is posted on the website under Advisory Board). Visit the ARC Center page and select "Quick Reference Guide". You will find all of the information necessary for completing and submitting your ARC Change Request Form. Monitor the status of your request by viewing the Active ARC log.

CERTAINTEED ROOFING ISSUES:

If your home was built between 2003 and 2007 using Certainteed (formerly Celotex)
Presidential Shake 50 Year Roofing Shingles, you may have issues entitling you to warranty repair or replacement.

Look for noticeable black streaks/drips of sealant (it almost looks as if your roof is crying) and separation or curling of the shingle layers.

If you think your roof might be affected, you will need to 1) have the roof inspected by a Certainteed certified roofing installer, 2) the roofing company will arrange an inspection by the Certainteed product rep, 3) the roofing company will help you file the warranty paperwork and 4) upon approval your roof will be repaired or replaced.
