The 2015 Annual Meeting of the Blue Valley Riding Homes Association has been scheduled as follows:

Two significant issues are included on the agenda this year. First, we want to amend the By-Laws of the Blue Valley Riding Homes Association to modernize the meeting and voting process. The Board proposes that the method for casting a vote be expanded to include electronic voting, provided we have the ability to verify ballots in order to preserve the integrity of the process in compliance with the Kansas Uniform Common Interest Owners Bill of Rights Act.

The second issue on the agenda is an increase in the annual dues. While no one on the Board enjoys asking our fellow neighbors to add to their annual financial obligation, it has become very clear that we must increase revenues in order to keep up with common area maintenance, including the pool and tennis courts. Neighborhood amenities attract buyers and help maintain property values. It should be noted that the Homes Association was formed in 1979 with annual dues set at \$120/year. There was an increase approved in the late 1990's to the current dues of \$200/year. Adjusted for inflation, the

original dues of \$120 would come to \$418 in 2015 dollars. The Board is asking now for an increase of \$120/year beginning 2016 to \$320/year, well under the rate of inflation.

Under our current contract with Deffenbaugh, we will have a 3% increase in trash collection to \$160/year. Therefore, if the dues increase resolution passes the total per home (including trash collection) will be \$480, which is slightly below the average for other area neighborhoods with community pools.

IF YOU DO NOT SUBMIT A TIMELY PROXY, YOUR VOTE WILL NOT BE COUNTED UNLESS YOU APPEAR IN PERSON AT THE MEETING.

RESOLUTION #1 - BY-LAWS AMENDMENT - INDICATE VOTE BY CHECK MARK

Article II, Section 5 of the By-Laws of Blue Valley Riding Homes Association currently reads as follows:

Unless a record date for voting purposes be fixed as provided in Section I of Article V of these By laws, then only members as defined in Section 6 of this Article II on the day twenty (20) days prior to any meeting of the membership shall be entitled to vote at such meeting. *Such vote may be viva voce or by ballot*; provided, however, that all elections for Directors must be by ballot upon demand made by a member at any election and before the voting begins....

It is resolved that Article II, Section 5 be amended to follow the guidelines of the Kansas Uniform Common Interest Owners Bill of Rights Act to read as follows:

...Such vote may be in person, by secret ballot, by proxy or by electronic means. Absentee voting is specifically allowed. In order to be counted, the absentee ballot must be verifiable and delivered at least 3 days in advance of the general membership vote. Proxies can be either directed or undirected; are valid only for the meeting at which cast; must be dated and not revocable; and a person, other than a member of the Board of Directors, may not cast undirected proxies representing more than 15% of the votes in the association.
