THE KANSAS CITY PARKS DEPARTMENT

The Kansas City, Missouri, Parks and Recreation Department provides facilities, programs and recreational opportunities for the community contributing to an esthetically pleasing environment and an enhanced quality of life.

The department operates and maintains close to 12,000 acres of parkland including 219 parks, 132 miles of boulevards and parkways, 47 fountains, 87 ornamental structures, 10 community centers, 27 lakes, 50 miles of trails and bikeways, 107 tennis courts, five golf courses and four museums.


EARTH911.COM


