

Notes from Our Neighborhood President

It's been four months since our 2008 Countryside annual meeting. Since that time, the board has been working implement the two initiatives you voted for, adding a Security Patrol and expanding beautification work. This edition of the newsletter will inform you of the progress that has been made to date.

Security Patrol Update

Four random 4 hour patrols are scheduled each week. KCPD Officer Brent Parsons, supervisor of the program, provides a monthly report on activity. A summary of results for June and July appears below:

- 30 traffic tickets were issued
- 3 residence checks were completed
- 17 car and 15 pedestrian checks were initiated
- 2 miscellaneous contacts were completed
- 19 calls for service were answered
- 38 city warrants were handled from arrests (23 of these were for a single person with multiple parking/traffic issues)
- 1 state/felony warrant was made with an arrest
- 12 intelligence reports were completed
- 1 of the arrests had a past criminal history of larceny (stealing) and burglary
- 1 party was occupying a vehicle wanted in a burglary in another area

- 1 car chase involved a stolen vehicle taken in a burglary from a nearby area
- 1 suspicious vehicle was found and surveillance was initiated by the property crimes unit.

The intention of these additional patrols is to identify Countryside as a neighborhood that is proactive in maintaining a safe and secure community. It is evident that a number of suspicious people and activities were challenged during this initial two month period. As residents, we need to act in partnership with the police department by reporting anything that doesn't look "right." Door to door solicitors frequently canvas our neighborhood; if you question the legitimacy of such a solicitor, please contact KCPD so that they may investigate. The KCPD non-emergency number is 234-5111. If you require immediate assistance, call 911. Our security patrol officers have noted that several of our blocks are very dark at night and that most burglaries are crimes of opportunity. Don't make it easy! Lights on, doors locked, valuables out of sight.

KCPD Launches Online Crime Alerting and Mapping Service

The Kansas City Missouri Police Department has unveiled a FREE web-based crime alerting and mapping service to empower KCMO residents and businesses to take a stand against crime in their neighborhoods.

"CrimeReports" allows citizens to see what crimes have taken place where they live and work — simply by typing in an address or zip code! You can see crimes for any location within Kansas City, Missouri boundaries — for any period of time — on easy-to-read incident crime maps. You can also request automatic daily, weekly or monthly e-mail alerts when crimes occur near your home, office, local school, or any location in the city you choose. The service, located at www.crimereports.com, or directly from the department's Web site (www.kcpd.org), provides neighborhood crime data in near real-time and is now available.

Rose Brooks Center has been selected this year to be the recipient of our community support during the Annual Picnic. Each year Rose Brooks Center's emergency shelter provides basic needs with support services for over 700 women and children who have fled domestic violence. The emergency hotline answers over 4,000 calls annually. Combined with outreach counseling and advocacy services in the courts, police departments, hospitals and schools Rose Brooks Center assists over 10,000 victims of domestic violence a year.

Please remember when you come to the Annual Picnic to bring new items to help the shelter residents. Rose Brooks is always in need of emergency care items since so many families arrive with very little of their own. Items such as women and children's personal hygiene supplies, (e.g. toothbrushes, toothpaste, deodorant, shampoo, etc.) or school supplies, (e.g. backpacks, notebooks, pencils, pens, etc.) and/or any monetary contribution you wish to give.

No gift is too small or too big.




Countryside Tour of the Nelson

Developer seeks Neighborhood Input for 51st & Main

Opus Plans Lifestyle Complex near Countryside Homes Association

At the suggestion of Countryside neighbor Tom McGee, representatives from Minneapolis-based developer Opus Northwest, LLC visited our July board meeting to discuss a proposal they are making to purchase the (land) 2.2 acres located on the NW Corner at 51st and Main from DST and develop it.

They are also meeting with the South Plaza Homes Association. The 51st & Main site is located within South Plaza's boundaries.

Opus's intent is to build a mixed-use complex up to 7-8 stories high, comprised of 230-240 high-end rental apartments (studios to 3-bedrooms), offices, street-level retail and adequate parking.

The current owner of the property, DST, the

developer that built Kirkwood, believes that Opus is a very strong developer with excellent plans for the space. Opus said their intent is to build "green" with LEED certification as their goal, and also retain the character and culture of the neighborhood.

Opus explained that the condo market is soft right now but the rental market is underserved in our area. By building high-end apartments initially, they intend to convert them to condominiums over the next five years as the market improves.

Their desire is to continue to look for a food store to move into the majority of the first floor space though they do not have any interested parties at the moment.

In an effort to alleviate concerns regarding density, DST took action. In the original plans for the area, DST had zoning to build a second tower like the one on the corner of 49th and Main. They have rezoned the property so that can no longer be done, thus trading potential significant office space for the less dense apartment space.

The Board will continue to meet with Opus to represent the interests of the neighborhood as the project progresses. If you have an interest, take a walk by the property and picture a new seven or eight-story building on the site. The 51st Street side is where the 7-8 stories would be. The building would be designed as terraced floors so that each apartment would have a balcony or patio and view of the Plaza.

The project requires re-zoning and Opus might request Tax Increment Financing and/or tax abatement from the City. They plan to make a go/no decision by next spring.

Appointment scheduling required for bulky item pickup

The City of Kansas City, Mo., Public Works
Department is notifying residents that starting Sept.
1 bulky item collections only will be available by
making an appointment. There also will be a 15item limit for appointments.

Residents can schedule an appointment by calling the 3-1-1 Action Center, a division of the City Manager's Office, at 311 or (816) 513-1313. Service related questions about a scheduled pickup should be directed to the 3-1-1 Action Center within 24 hours of the collection date.

Bulky items include refrigerators, stoves, freezers, dishwashers, dryers, sofas, desks, tables, doors, lawn mowers and carpet. The City does not consider an item as bulky if it can be accommodated by regular trash service. Bags, boxes, vacuum cleaners and small electric appliances and fans are not bulky items.

Residents with debris from remodeling and construction projects should contact a private solid waste company.
