## **Neighborhood Diplomacy**

In light of continued dramatic change in the real estate market, the Board of Directors, on behalf of homeowners comprising the Homes Association of Northwood Trails, wants to bring forward an amendment for discussion and possible addition to the Northwood Trails Declaration of Restrictions.

Given the increase in Northwood Trails homes used as rentals, the Board has heard community interest in limiting the scope of rentals, notably those owned and operated by limited liability corporations or other large investment companies who have at times rented to multiple unrelated parties.

The board understands that a decision of this magnitude should be, and will be, put to a decision by NWT homeowners. To complete this amendment, it would require two-thirds (66%) of homeowners to have notarized signatures.

Other area homes associations dealing with similar issues successfully limited rentals, within reason, through an amendment to the Declaration of Restrictions. What the board will ask NWT homeowners to decide is whether or not to require a purchaser to own a home for several years before being allowed to rent it out. This would theoretically dissuade those looking to purchase-to-rent in the neighborhood, while allowing the homes that have been longtime rentals to continue. If passed, this would not impact any current renter in the neighborhood

The Board will sponsor an online town Hall via Zoom in early August at a date and time to be determined and announced on eNeighbors. This information session will be designed to answer any and all questions and concerns on this issue.

This issue will be decided by Northwood Trails homeowners, and will require notarized signatures for two-thirds of homeowners. If you are a notary and could help lead a signature collection effort, please email peterfmundo@gmail.com.

Have you noticed trees or shrubs with yellowing leaves in our neighborhood? Iron chlorosis is a yellowing of plant leaves caused by iron deficiency that affects many desirable landscape plants. Some leaves will look yellow with green veins. This area is iron deficient. We have treated our pin oak a couple times in the last several years, and it needs it again.

Also, our oak leaf hydrangeas just received a dose of iron. The huge pin oak by the pool parking lot will be receiving iron injections. Treating with iron will help the tree be healthier and better able to resist diseases and insects. It also helps promote new growth and the leaves will once again be their dark green color. If you have questions about iron treatments for your trees or shrubs, contact Johnson County Extension at 715-7000.

Volunteers have saved NWT homeowners thousands of dollars in recent years. Here are a few jobs done by our grounds committee this past month:

**Kathy & Orin Swift** teamed with **Barb Mueller** to weed, prune and mulch the perennial bed stretching across the dam west of the pond.

Chuck & Carol Nigro weeded the large beds by the pool parking lot. Chuck refilled the iron solution injection jug on our convalescing big oak in that area and continues to water the new maple tree.

Steve Karasek completed repairs and painted the 117th Street and Northwood Drive entrance monuments and installed handsome solar safety ground lights lining the pool entrance ramp. ideas. After that, follow up with those committees to see if your idea is a neighborhood priority or what it will take for the project to come to fruition.

*One last thing:* May 1 was the dues payment deadline. Late fees began to accrue June 1. We may be moving those due dates up a month in 2024 in an attempt to eliminate any confusion vis-à-vis timely pool access. If you have any questions please don't hesitate to ask.

### Creekside sanctuary

Where in NWT is the best place to take your kids or grandkids for a great nature walk and exploration? The kids will love walking out on the stones of Mill Creek and playing with all the rocks while you enjoy the new bench at the Northwood Trails Mill Creek Destination!

From the north, go to the playground parking lot (bottom of Millview Road). At the west end of the lot, you will see a trail going left between two large evergreen trees. Take that trail and walk about 200 feet. You will be on the east side of Mill Creek. Turn west (right) on the first spur and you will see a concrete walkway that leads into the creek.

From the south, walk north on the trail that runs behind the Millview Road homes and curves into the woods, then turn west (left) on the spur leading to the creek.

Can you build the tallest rock sculpture? How many rocks can you stack to build your stony creation? Mosey on down to our new Mill Creek Destination and see what you can do! Have someone photograph you standing behind your build and post it on eNeighbors.

Tony & Regina Wittman repaired fences, moved shrubs and perennials, added shrubs to the 117th Street entrance beds, and kocked out weeding and pruning tasks in many of our NWT common areas.

In the following months you will some trail sections being repaired or replaced. Also, the log fence lining Ridgeview damaged in a single-truck collision will be repaired.
