Spring greetings, neighbors! Don't forget to grab the required architectural review request form



at eNeighbors and email it to the review committee as you plan your spring and summer home exterior or landscape improvements. Most requests are routine, but it's best to abide our NWT rules and avoid costly changes later.

This month's deed restriction refresher comes from No. 13 on the matter of exterior basement foundations and walls. It states, "Exterior basement foundations and walls which are exposed in excess of eighteen inches (18") above final grade level at any point shall be painted and in the same color as the house, or covered with siding compatible in color and material with the structure."

As of this writing, colder temperatures were shrouding our little wooded hamlet in the Osage Cuestas at the beginning of March after an extended February dry

period that saw temperatures climb at times into the 70-degrees range.

No matter what surprises Mother Nature throws our way, the days keep ticking by, turning quickly into weeks. That's why this is an opportune time to remind neighbors that your Association payments are due in full by the new

deadline of April 30. Late fees apply beginning May 1. That's a change from the past made in an effort to get all members in good standing by pool season kick-off.

When you're paid up, you're an NWT Member in Good Standing (MIGS, in the parlance of our times). Paying dues is a legal responsibility entered at the purchase of your home. Being a MIGS is a must for using amenities such as the pool. You may pay with a debit/credit card at ha-kc.org. Allow time for processing.

This spring, you'll notice irrigation and tree maintenance work commencing in common areas about the time the pond's aerators and bubblers power back to life. Look closely and you'll see a resolute Social Committee pulling off the Easter Bunny's visit with typical deft proficiency and esprit.

Let these community quality-of-life enhancers serve as a reminder that your dues exclusively fund the maintenance, operations and community events of your Northwood Trails Homes Association.

Spring greetings! The Northwood Trails Homes Association Board of Directors wishes to make sure



every neighbor knows Association members are invited to our monthly board meetings. The first 30 minutes are available for neighbors to ask questions, relay concerns, report problems or offer solutions. E-mail and social media can be great tools, but the best way for your volunteer Board

to hear your concerns and try to address them is for us to listen directly and speak with you at our monthly Board meetings. Our upcoming sessions are set for 7 p.m. Tuesday, March 12, and 7 p.m. Tuesday, April 9, both at Grace UMC across Ridgeview Road from NWT.

Please note that renting a portion of one's home, via a long-term rental or short-term renting platform such as airbnb or Vrbo is against a Northwood Trails deed restriction (available at NWT's eNeighbors page > documents > legal documents > deed restrictions > Section 2) that states, "The real estate above described shall be improved, used and occupied for private residential purposes only. Any dwelling unit erected or maintained on any of the lots hereby restricted shall be

designated for occupancy by no more than one family."

Aside from that clear legal restriction, the long-standing concern is short-term renters aren't compelled to respect our rules and customs regarding speed limits, parking or noise. While it's rare that short-term renters themselves case neighborhoods for crimes of opportunity, a 2021 peer-reviewed study published in *PLOS One* found increased airbnb/Vrbo listings "essentially erode a neighborhood's natural capacity to manage crime" since fewer units are home to watchful, knowledgable neighbors with long-term buy-in to our real-life social network. Unfortunately, such violations have popped up again and will be handled externally by the Northwood Trails attorney.

The NWT Declaration of Restrictions amendment restricting limited liability corporation property management ownership has already received more than 75 signatures out of about 300 needed. There is no deadline to obtain them. We expected a slowdown in momentum during the winter months and know spring and summer events will bring more opportunities for notarized signatures.

it and check for overhanging limbs that could harm bicyclists riding through. Adults and children use these paths regularly, so let's make them safe for everyone.

them to the holders once you are done. If your children are playing in the sand, make sure the sand remains in the court. Sand put into the nearby shower drain clogs the drain and results in costly repairs. If your child digs holes, please put the sand back into the court so it is usable and safe for players.

Please report the following to Gerry B.:

Sections of neighborhood trails that need to be replaced. Give exact locations.

Dead or mostly dead trees. Give addresses.

Anything in the common areas that has seen better days and should be repaired or replaced.

Any time you see entrance sprinklers or any common area irragation running after 10:30 a.m.
