Recent AT&T Solicitors: Westmont had solicitors from AT&T calling door to door despite our NO SOLICITING signs. Board President Shirley Knese contacted the police and had these solicitors removed. The police officer got the name of the solicitors' supervisor. Shirley contacted the supervisor directly and asked that AT&T keep their sales employees out of Westmont. AT&T claimed they were only calling on existing customers, thus leaving them exempt from the Overland Park ordinance noted on our NO SOLICITING signs.

Further conversation with the police officer revealed information Shirley felt should be shared with Westmont residents. Cities surrounding Overland Park require a license for people to sell door to door. Overland Park does not require a license, resulting in sales people funneled into Overland Park. The police officer recommended that we, as residents, go to a City Council meeting and request the city require a license for door-to-door soliciting as do surrounding cities. A date to attend the Council meeting will be announced in a future Westmont Newsletter.
