## Your board at work

- ▶ Fencing plans are proceeding for Antioch, along with appropriate landscaping that will probably be done next spring since winter's almost here. Putting additional fencing into the gaps on Westmont's 119<sup>th</sup> St. fence is also in the works. Thanks to <u>Don Niemackl</u> and <u>Shirley Knese</u> for their efforts.
- ▶ Remember: your **new Deffenbaugh trash container** must be placed a foot from the curb with the arrows pointing toward the street. If you're unable to push your barrel to and from, ask a neighbor to assist. Or, if you'd like to switch to a more manageable 35-gallon barrel, call Deffenbaugh at 631-3300 to make arrangements; there may be a fee so ask first. (You can also request a 95-gallon container). .Deffenbaugh confirmed you can have up to 6 bags of yard waste per week. Stickers will need to be purchased from Deffenbaugh for 7 or more bags.
- ▶ Your board is aware and in compliance with the **New Laws for Kansas Home Associations** and HAKC will advise the board if needed.
- ▶ The board is actively working together to review lawn and landscaping services. .
- ▶ Diseased trees in the neighborhood have been marked and will be removed in January.
- ▶ "Those three lucky homeowners who **won a month's paid maintenance fees** at the annual meeting drawing in October, "reports treasurer <u>Jake Schulzinger</u>, "can expect to see their gifts in January. Also, I've identified the replacement bulbs needed for the **two entrance monument lights**. All I need do is buy and replace them and make sure the controls are set properly."
- ▶ The board will meet Dec. 13 to select its officers for 2011 and discuss goals and priorities for the New Year.
