**Waste Removal Contract Signed:** After negotiations and a thorough review of submitted bids, President Beverly Kits and her committee members recommended to the Board that Deffenbaugh/Waste Management continue as the company to provide garbage/recycling/yard waste removal. The board unanimously approved the contract.

## VICE PRESIDENT'S REPORT

<u>Winter Fence Damage:</u> Shirley Knese reported Guier Fence Company, the original installer of our perimeter fence, will repair the fencing damaged during the winter storms. The replacement materials will match our current fence. Additionally, Guier will install reinforcement rods for extra support. This repair will occur sometime this spring.

<u>Garbage and Recycle Bins</u>: The bins that contain garbage or recycle materials should be put at the edge of your driveway near the street. If you are unable to do this or need a smaller bin or a wheel replaced, call Deffenbaugh at 913-631-3300.

Through the week, bins should be stored in your garage or, if stored outside, they should be in the back where they can't be seen from the street. Our pickup day is Wednesday. Anytime from Tuesday PM to Wednesday PM., bins may be on the driveway.

**TREASURER'S REPORT:** The February financial statements and expenses were reviewed and discussed at the March board meeting. All agreed financials to be in order.

**LAWN AND GROUNDS:** Many homeowners contacted our Lawn and Grounds Director John Rudzinski to let him know they were pleased how TLC managed our last (hopefully!) snowstorm snow removal. Thank you for taking the time to do that!

Your Yard Irrigation System: It's about time to turn on your irrigation system. TLC provides this service for a fee and can be reached at 913-780-5296. Or contact a provider of your choice.

<u>Remember--Don't Over Seed Your Yard Yet.</u> TLC will apply pre-emergent chemicals mid March to early April, weather permitting. If you want to over seed or repair lawn areas, wait at least three weeks after pre-emergent chemicals are applied. Then spread your grass seed and water it in.

Mowing Day: TLC will mow our yards on Fridays, weather permitting.

Spring Cleanup: TLC will do spring cleanup mid March to early April, weather permitting.

Shrub Trimming: TLC will trim shrubs the week of June 17. Details will be in the May newsletter.
