**Lawn and Ground Activities for December –** During the first half of December, Precision will perform final leaf cleanup and then an application of winterizer fertilizer the week of December 18th, weather permitting. Winterizer contains high levels of nitrogen and helps the roots of the grass absorb and store nutrients. The roots continue to grow until the ground eventually freezes. These nutrients are stored and ready to go, so when spring comes around, your lawn hits the ground running. Specific dates will be communicated via Directory Spot and Mailbox Flyers.
