Wild about Birds



Join members of the Westwood community who will have birdhouses and birdfeeders on sale on behalf of Charlie from Topeka during the annual garage sales on June 1. Featured will be over 200 birdhouses/feeders, bat, butterfly, squirrel, and toad houses. These were made by a retired plumber whose hobby and passion began when his wife Gladys wanted him to build a birdhouse and feeder to attract birds to her garden. He used the book *Birds and Blooms* for his initial design. Next, he built one for his daughter and she took it to work ... others saw it and then *everyone* wanted Charlie to build another birdhouse/feeder! Thus the nickname "Wild about Birds" was proclaimed.

Charlie used to set up a booth in Topeka's City Market and sell them on Saturdays. Charlie has a leg injury and now does not have the stamina to set up and sell items at the market. A representative from an elder care agency contacted a resident in our Westwood Park community, and arrangements have been made to sell them at the Westwood Park Pavilion on Saturday, June 1.

Charlie's desire is that the items will be sold to individuals who share his interest and passion for birding. He has priced the structures reasonably, ranging from \$2.00 - \$25.00. His ingenuity, craftsmanship, and love for birding make

A "Legacy Scrapbook" has been started, and people who purchase the birdhouses are encouraged to send a picture by email and write a brief description of the location where the structures are placed. Q&A with Jan Marcason at Annual WPHA Meeting

Q: The pervious sidewalks in Westwood Park do not seem to be holding up well. There were problems with the trash trucks running over and cracking the sidewalk. Will they be repaired?

JM: Frank Gibbs, the landscape architect for Westwood Park, has contracted with a business to repair the sidewalks as weather allows.

Q: How can we change the election cycle to prevent single issues from being on the ballot during off times when few people vote? What does the City Charter say about election cycles?

JM: The City Charter doesn't set up election dates except for the primary and general elections every four years. Issues cannot be on those election dates, just the Mayor and Council election and the Municipal Judge retention questions. The election dates are set by statute. Section 115.123, RSMo. sets up the following election days:

- First Tuesday after the first Monday of April, August and November;
- Any date established by Charter. (This is a new part of the statute and hasn't been used yet to set election days.)
- First Tuesday after the first Monday of February for bond elections only.

Q: There were banners along State Line (State Line Link) from I-435 to Southwest Boulevard to indicate the cooperation between Kansas and Missouri. Two of the banners in the Westwood area were removed to accommodate the Google poles that were installed. Jim Donovan saved the two banners, but one of the poles is now next to a tree, so if the banner is put back up (which he would like the city to do) the view would be blocked. What is the process to determine if a tree should be removed? Would the city re-attach the banners?

JM: I have asked David Panek, the supervisor of LDD permitting, for a response.

Q: Woodside is planning a huge residential development to adjoin the health facility. How do we know that the sewers in Kansas City can manage the increase in sewage that will come as a result? Woodside has been asked, but there has been no response. What are the procedures in the City when a development in another state will impact our infrastructure?

JM: JCW would be reviewing construction of any sewer, which would most likely be built by the developer. JCW would look at the capacity of the sewer system and coordinate with KCMO Water Services should there be any concerns. •
